Dear New Customer:

Welcome to **Harris County UD 6**. The following information is being provided to help you become familiar with the policies, procedures and rates relating to your water and sewer service.

The district requires a \$300.00 tenant deposit when presenting owner affidavit for leasing property. If the affidavit is not presented the tenant deposit required is \$800.00. Additionally, a \$29.00 transfer fee is due. Both deposit and transfer fee are due prior to service initiation. Owners will only require transfer fee.

**The deposit (if required by the district) and application fees and a signed Customer Service Agreement is required to set up service.*

The deposit will be applied to your final bill. If there is a credit balance on the account, a refund check will be issued, and processing time will take 6-8 weeks from the final bill date.

**If you are wanting same day service, please visit our office prior to 2PM to process your request. Inframark does not*

A 10% penalty of the unpaid will be assessed if payment is received after the due date. This amount is shown in the "AFTER DUE DATE" block on your bill.

If your account becomes past due, a disconnection notice will be sent to your address that may include your past due and current balance. Your bill will be assessed a \$19.13 delinquent letter fee, on top of the 10% penalty. Specified on the disconnection notice is the amount that is due to avoid termination of service. If a door tag is placed at the residence a \$10.00 tag fee will be added to your account. If full payment is not received as directed on the disconnection notice, your service will be disconnected. If service is disconnected, a \$50.00 reconnection fee will be added to your account as well as a \$75.00 disconnect deposit.

The full balance of your account will be required to restore service, payable by credit/debit card, cashier's check, or money order only. The payment for disconnection of service is due by 3:30pm CST Monday - Friday to restore with same day service. If your district offers after-hour services, payment made after 3:30pm CST will be subject to after-hours fees.

NOTE: *Once an account is turned off due to a non-payment: payments made by checks, QR Readers, or mailed are not acceptable forms of payment to restore services.*

Garbage Service is not provided by Harris County UD 6. Please contact your community HOA.
